

PACK BASIC LICENSE

1. ADD LIBRARY S.L. ("ADDLIBRARY"), Id. # B-64 513 732, addressed at Plaça Paradís, 2 2ª, Vic, 08500, Barcelona, Spain, licenses to the Licensee, as defined below, certain rights in the terms provided for in this license agreement (the "License") for good and valuable consideration the sufficiency of which is hereby acknowledged.
2. Hereby ADDLIBRARY licenses to the LICENSEE certain exploitation rights on NON EXCLUSIVE basis and limited to the exploitation means defined at clause 4 below in and to [Number] of sound effects which collective title, reference number and price are the following:

Hereinafter, these sound effects along with all files or supports containing the same are referred to as "PACK BASIC".
3. This License is conditioned upon effective payment of the consideration (Price) set up at clause 2 and is valid throughout all territories of the world (the "Territory") to the longest term permitted by applicable laws or in perpetuity in so far as possible (the "Term") restricted to exploitation means specified at clause 4 above. THIS LICENSE IS NOT A SALE.
4. LICENSEE is authorised hereby to exploit the PACK BASIC for unlimited synchronization uses for an unlimited number of times in every type of formats and supports, except prohibited uses as defined in the following clause. In particular, LICENSEE shall be allowed to use the PACK BASIC in context with recordings and products accessible by the general public by means of personal and corporate web pages, advertisement, radio, commercial bumpers for radio and television, public-address and telephone systems, presentations, podcasts, toys, merchandising products etc.
5. In no event LICENSEE shall be deemed to be authorised to perform as the following prohibited uses ("Prohibited Uses") in connection with the PACK BASIC:
 - broadcast and diffusion of the PACK BASIC without synchronization in other work or recording by any and all transmission means including but not limited to all radio, internet and wireless means; and,
 - synchronization of the PACK BASIC into sound recordings for reproduction, manufacture, distribution, rental, lease or sale of sound supports.
6. This license is personal to LICENSEE. In no case LICENSEE may assign or transfer any or all rights and/or authorisations granted hereby to third parties.
7. LICENSEE shall not use the PACK BASIC in a context which is immoral or against human rights.
8. ADDLIBRARY shall allow access by LICENSEE to an MPEG-1 Audio Layer 3 file ("MP3") containing the PACK BASIC. The said MP3 file shall remain accessible for thirty (30) days upon payment of the Price set up at clause 2 and beyond the said term subject to commercial availability.

- 9.** The Price set up at clause 2 is the complete consideration payable by LICENSEE to ADDLIBRARY against this License and is a gross amount subject to the application of the relevant Tax Laws. LICENSEE acknowledges and agrees the license is conditioned upon payment of the said Price and it shall be null and void unless the Price is paid no later than thirty (30) days upon presentation of an invoice by ADDLIBRARY.
- 10.** ADDLIBRARY shall be entitled to terminate this license because of default by LICENSEE or due to a cause of force majeure such as termination of ADDLIBRARY's rights in and to the PACK BASIC. ADDLIBRARY shall provide LICENSEE with a notice in writing and LICENSEE shall cease exploitation of the PACK BASIC immediately upon receipt of the said notice and will refrain from any further exploitation. LICENSEE waives any and all claim or action except for return of the Price of the License.
- 11.** ADDLIBRARY and ADDLIBRARY's successors and assigns are authorised hereby to keep, treat, assign and transfer to third parties worldwide and in perpetuity any personal information relevant to LICENSEE or LICENSEE's personnel which is known by ADDLIBRARY by reason of this License in so far as relevant for the purposes of this agreement and ADDLIBRARY's corporate purposes.
- 12.** This License and its validity, construction and effect is governed by and construed under the laws of Spain, excluding Spanish choice of law provisions, and subject to the jurisdiction of the courts in the City of Barcelona. The parties waive any and all action which might correspond in any other place of Jurisdiction.
