

PLATINUM LICENSE | MASS MEDIA WORLDWIDE USES

- 1.** ADD LIBRARY S.L. ("ADDLIBRARY"), Id. # B-64 513 732, addressed at Plaça Paradís, 2 2ª, Vic, 08500, Barcelona, Spain, licenses to the Licensee, as defined below, certain rights in the terms provided for in this license agreement (the "License") for good and valuable consideration the sufficiency of which is hereby acknowledged.
- 2.** ADDLIBRARY licenses to the LICENSEE certain exploitation rights on NON EXCLUSIVE basis and limited to the exploitation means defined at clause 4 below in and to the following musical work and recording:

The said musical work and recording are inseparably referred to hereinafter as the "Music".
- 3.** This License is conditioned upon effective payment of the consideration (Price) set up at clause 2 and is valid throughout all territories of the world (the "Territory") to the longest term permitted by applicable laws or in perpetuity in so far as possible (the "Term") restricted to exploitation means specified at clause 4 above. THIS LICENSE IS NOT A SALE.
- 4.** This is a PLATINUM License. MASS MEDIA COMMERCIAL AND PUBLICITY USES except prohibited uses ("Prohibited Uses") as defined at clause 5 below are authorised hereby. In particular, LICENSEE is authorised hereby to exploit the Music for unlimited synchronization uses for an unlimited number of times as follows:
 - a.** synchronization of the Music into audiovisual and sound recordings intended for the public acknowledgment of one product or service (advertisement, promotional clips and publicity) ads for such communication to the public, including telecommunication and wireless access, throughout the Territory by all broadcast and diffusion media and systems including without limitation all radio, television, internet and wireless means; and,
 - b.** synchronization of the Music into audiovisual works and recordings (including but not limited to full-length theatrical films and television programs) for such communication to the public, including telecommunication and wireless access, throughout the Territory by all broadcast and diffusion media and systems including without limitation all radio, television, internet and wireless means; and,
 - c.** synchronization of the Music into audiovisual and works and recordings as described in paragraphs a and b above for direct exhibition in theatres and non-theatrical facilities throughout all or part of the Territory and for diffusion of the Music in context with public performances and activities, regardless whether a price is charged for accessing the facilities where the event is taking place. Includes diffusion in context with theatrical and scenic performances, expositions, fairs, expositions, festivals, congresses and museums and publicly and privately owned collective transport carriers; and,
 - d.** synchronization of the Music into other works, recordings, and products for reproduction, manufacture, distribution, rental, lease or sale of copies, supports and products embodying the Music inseparably including videogames, software products, toys, educational products and merchandising; and,
 - e.** fixation of the Music into a sound support for public-address and telecommunications systems within closed or opened air facilities with or without advertisement purposes including public-address systems, Short Message Services (SMS), background music in facilities opened to the public including but not limited to collective transport carriers whether of public and private ownership, automatic answering machines and waiting and hold on the line services.

- 5.** ADDLIBRARY specifically reserves any and all rights and usages not specifically licensed to LICENSEE hereby. Without limiting the generality of the foregoing in no event LICENSEE shall be deemed to be authorised to perform the following prohibited uses ("Prohibited Uses"):

 - broadcast and diffusion of the Music without synchronization in other work or recording by any and all transmission means including but not limited to all radio, internet and wireless means; and,
 - synchronization of the Music into sound recordings for reproduction, manufacture, distribution, rental, lease or sale of sound supports.
- 6.** This license is personal to Licensee. In no case LICENSEE may assign or transfer any or all rights and/or authorisations granted hereby to third parties.
- 7.** LICENSEE shall not use the Music in a context which is immoral or against human rights.
- 8.** Non-economic moral rights of authors are reserved hereby.
- 9.** ADDLIBRARY shall allow access by LICENSEE to an MPEG-1 Audio Layer 3 file ("MP3") containing the Music. The said MP3 file shall remain accessible for thirty (30) days upon payment of the Price set up at clause 2 and beyond the said term subject to the commercial availability of the Music.
- 10.** The Price set up at clause 2 is the complete consideration payable by LICENSEE to ADDLIBRARY against this License and is a gross amount subject to the application of the relevant Tax Laws. The Price is the ROYALTY FREE flat fee for any and all uses licensed. No payments to third parties are applicable. LICENSEE acknowledges and agrees the license is conditioned upon payment of the said Price and it shall be null and void unless the Price is paid no later than thirty (30) days upon presentation of an invoice by ADDLIBRARY.
- 11.** If LICENSEE makes use of the Music synchronized into a work or recording including titles of credit LICENSEE shall include a title of credit in the following form:

- 12.** ADDLIBRARY shall be entitled to terminate this license because of default by LICENSEE or due to a cause of force majeure such as termination of ADDLIBRARY's rights in and to the Music. ADDLIBRARY shall provide LICENSEE with a notice in writing and LICENSEE shall cease exploitation of the Music immediately upon receipt of the said notice and will refrain from any further exploitation. LICENSEE waives any and all claim or action except for return of the Price of the License.
- 13.** ADDLIBRARY and ADDLIBRARY's successors and assigns are authorised hereby to keep, treat, assign and transfer to third parties worldwide and in perpetuity any personal information relevant to LICENSEE or LICENSEE's personnel which is known by ADDLIBRARY by reason of this License in so far as relevant for the purposes of this agreement and ADDLIBRARY's corporate purposes.
- 14.** This License and its validity, construction and effect is governed by and construed under the laws of Spain, excluding Spanish choice of law provisions, and subject to the jurisdiction of the courts in the City of Barcelona. The parties waive any and all action which might correspond in any other place of Jurisdiction.
